Shared Facility Replacement Reserves and Operating Expenses: The OTVOA Board

Expenses: The OTVOA Board continues to work with the association's legal counsel for further legal analysis and guidance on the reserves for the shared facilities. A notice went with the invoice to the condominiums regarding levying interest on late payments of shared operating costs as per the Easement and Cost Sharing Agreement.

South Payne Street: The survey of South Payne Street was completed by R.C. Fields & Associates. The project included a title search and stake out of the portion of South Payne Street in OTV. This survey provided a definition of the property line clarifying the responsibilities of the townhouses, the condominiums, and the city.

Replacement of Roundhouse Patio Door: At its September meeting, the townhouse board reviewed an analysis by Cole & Denny Architects regarding replacement of the Roundhouse patio door. The townhouse board voted to approve a bid recommended by the Management Committee to replace the sliding door with a french door with the addition of energy saving E glass.

The Budget Process and Reserve Study: The reserve study is completed and once approved by the townhouse board it will be available to the townhouse community. The study is in two parts: one that examines townhouse only assets and one the examines shared facility assets. The townhouse Finance Committee received draft budgets from the committees and presented a draft 2025 budget to the townhouse board for approval. The board will share the draft budget in advance of the October board meeting and approve it at the annual meeting.

Architectural Review Board

Paul LaRuffa, Chair

On behalf of the Architectural Review Board ("ARB"), I'm excited to share recent updates that help keep our community a great place to live!

New ARB Member: I'm pleased to announce that Rich Sikora has joined the ARB. You may know Rich as a member of OTV's Safety Committee. He and his wife, Yun-Ho, have been residents of OTV for six years and recently welcomed new puppy, Pedro. Rich has an engineering background that makes him a great fit for experienced insights on ARB matters. Thanks to Rich for sharing his time and talents!

Annual Home Inspection Update: The ARB completed OTV's annual home inspections the week of September 16. At the time of article submission, preparation of violation notices is underway for distribution to homeowners.

As a reminder, the ARB automated the annual OTV inspection process using HOALife software in 2024. Also, certain common elements within the OTV community were added to the scope of inspection including the Roundhouse and OTV mailboxes.

The 2024 Annual ARB Inspection resulted in a total of 131 violations involving 98 properties. Individual homes may have multiple violations due to the nature of infraction, resolution type, and cure period. For example, a house could have window trim with peeling/blistering paint and a faded kickplate. The HOALife system tracks these violations separately and generates a unique email or letter for each violation.

The ARB notes that many violations result from peeling or blistering paint, as well as evidence of wood rot. Similar to last year, faded kickplates are another common issue that requires homeowners' attention.

With maybe a couple of exceptions, the 131 violations do not include any for general cleanliness. We've decided to ask the board to send out an email reminding homeowners that it's their responsibility to maintain their property in a clean and sanitary manner.

ARB Approval Reminder: So far this year, there have been six instances of exterior projects undertaken by OTV homeowners who failed to obtain ARB approval prior to project commencement. Please note that homeowners must obtain ARB approval before making exterior modifications to their property or replacing certain exterior home components such as roof, windows, doors, fences, etc. Remediation of well-meaning fixes and improvements not aligned with ARB guidelines can prove to be costly. Please review the ARB guidelines and application on the OTV website as part of your project planning activities.

Summer is officially over, and the start of fall has brought significant rainfall, delaying our scheduled turf treatments. Chapel Valley will be out the first week of October to complete overseeding and soil aeration. Now that the heat has subsided, Ground & Services will focus on long-planned plantings to enhance our community's appearance throughout the fall and winter months. As mentioned last month, this is the ideal time to plant perennials and shrubs. Your local garden nursery can provide the best information for our specific area.

Ornamental Plant Recommendations

Perennials

- Hellebores: Bloom in late winter to early spring, providing early color.
- Sedum: Hardy and add texture to winter gardens.

Shrubs

- Boxwood: Evergreen and provide structure throughout the winter.
- Winterberry Holly: Bright red berries add color and attract birds.

Administrative Update: The Ground & Services committee has integrated the cost of irrigation into the HOA reserve study. The committee is currently working on Requests for Proposals (RFPs) to compare the costs of repairing and upgrading our aging irrigation system. The last system upgrade was 12 years ago.

Thank you to the OTV residents who have reported issues. Your timely reports help us address problems efficiently. The Ground & Services Committee appreciates your commitment to our community.

Sliding Glass Door Replacement:

The long-anticipated sliding glass door replacement project will commence on September 23, 2024. The selected contractor, Katchmark, has requested that the replacement project occur one building at a time starting with Building 1; proceeding sequentially; and concluding with Building 5. Katchmark estimates that the smaller buildings (1 and 2) will take about 8 days to complete. The larger buildings (3, 4 and 5) will take approximately 16 days for each building. We expect the entire project will take about 60 to 80 days to complete.

Katchmark will be setting up a staging area in the parking lot island between buildings 1 and 2. The area will include a sea container that will store the sliding glass doors, a port-a-potty, and a trash bin.

Sentry Management will be contacting those Condo Owners in Building 1 who requested to have their sliding glass door(s) replaced to schedule the work. Owners should plan to either be home during the sliding glass door replacement, or have a designee (i.e., friend or family member) present during the construction.

Please note that Katchmark will repair/ paint any molding damaged as a result of the sliding glass door replacement. Katchmark will apply semi-gloss white paint to the molding unless the owner has paint available for touchups. In this case, Katchmark will use your paint to complete the touchups.

The Condo Board has also retained Carlson Structural Engineering to oversee the construction project. This is in keeping with the Condo Board's recognition that these projects need to be overseen by experts and not community members so that we get it right the first time!

During the construction Katchmark will be using the elevators. We ask for your patience during the construction. If you have any questions, please contact Christie Beruete of Sentry Management, Barbie Poole, OTVCUA Vice President, or Karl Kalbacher, OTVCUA President.

Electric Vehicle Charging Stations:

The Greenspot subcontractor for installation of the EV Charging Systems, (COIL), was on-site the week of 9/14 and completed a site survey. The four EV Charger Ports will be installed in the rear parking lot area between Buildings 1 and 2 near the trash enclosure.

Shared Facilities Reserve Fund: Much has been written about the Condo Board discontinuing funding into the Townhouse controlled Shared Facilities Reserve account. The Condo Board has redirected these monthly contributions to a Condo controlled *Shared Facility Reserve account*. Provided below is a summary of the contributions made into this account in 2024.

The Condo Board continues to comply with the requirements in the 2003 Amended Easement and Cost Sharing Agreement to fully fund our portion of the Shared Facilities Replacement Reserve. The Condo Bylaws, however, do not permit the comingling of funds. Accordingly, the Condo Board is correcting a past mistake that allowed these funds to be comingled.

Payne Street Parking Spots: The Townhouse Board approved funding to complete a property survey of Payne Street to determine land ownership between the Condos and Townhouses. These costs were entirely borne by the Townhouse Board.

This is unfortunately a very old issue that I thought was resolved in 2019 when I was the President. Back then, the Townhouse Board told me that Condo cars were parking in Townhouse spots and Condo owners were being "ticketed" by the Townhouse Parking Authority – being an old regulator, I was pretty sure they didn't have authority to ticket Condo owners on Condo parking spots.

In response to these concerns, I raised the issue with the City of Alexandria Planning Department – the entity that regulates land use development. The city responded in an email – see below.



Kevin,

To clarify, you are determining if it is the responsibility of the Condo Board and the Townhouse Board to maintain this portion of S. Payne Street? If this is the case, then I do not think the City would get involved, this is something that is hopefully outlined in the COA or HOA docs for each board.

I can say that for this strip of S.Payne Street, the roadway and parking spots are within the Condo parcel, while everything east of the curb, including sidewalks and stoops, belongs to the HOA of the townhouses. The site plan appears to confirm this:



The city's plat graphic above shows the property division at the edge of the sidewalk in a straight line. The visual is cut off and does not show the yellow line extending south of the Payne Street and Roundhouse Lane. Provided below is the property plat that shows the property divisions further south.

The 2024 property survey completed by the Townhouse Board appears to agree with the property division as reported by the

city in 2019. If you have time, inspect the survey stake at the bollards and Payne Street and the orange colored survey spray paint dots. These dots and the stake form a continuous line along the sidewalk edge.



Condo Financial Investments: We were doing too well!!! Our \$250K certificate of deposit (CD) was called because it was earning 5.7% in interest and as we all know interest rates are dropping. We made \$7K off this CD and have reinvested the profit into another callable CD at 4.65%. The balance of funds (\$250K) will be invested in a non-callable CD at 4.35%. Our financial advisor believes the FED will move to drop interest rates next week and so he suggested going with a non-callable CD







The book for September was An Immense World: How Animal Senses Reveal the Hidden Realms Around Us by Ed Yong. The author tries to illuminate the reader's understanding of how other animals experience their surroundings. Humans as well as animals live within their own "sensory bubble" or Umwelt as the author refers to it. He leads us through explanations of how humans and animals have different capacities and capabilities of vision, sound, touch, smell, taste and the like. The book is filled with amazing and fun facts about the animal world and how humans may have limited ability to accurately imagine how animals use their senses to experience the world.

Very few in the group made it past the first couple of chapters. Most felt it was too in depth and overloaded on science. However, for those of us who did finish, there were lots of amazing things to learn.

For example, most animals can see ultraviolet light, but humans cannot; this makes it very difficult for us to perceive what animals actually see. The author suggests if we better understood animals' "sensory bubble" we could change our built environment to prevent harm to them. Many examples are provided of the comparison of what human capabilities are in relation to animals.

Reminder: The Book Club maintains the OTV library. We accept books that have been published in the last 10 years. We do not have room for cookbooks, travel books or self-help books. Books that we do not have room for can be donated to The Alexandria Library, 717 Queen Street, Discover Books which has a bin in the parking lot of Safeway, 500 S Royal St, or any thrift shop.

The group rated the book 1 out of 5 stars.

The annual Fall Cemetery Cleanup will be held on Saturday, October 19 from 9:00 AM to 11:00 AM. We will meet at the corner of Wilkes and Hamilton Street at 9:00AM for sign-up (this intersection is

inside the cemetery complex, see photo)

Everyone will have to sign an Alexandria City Volunteer waiver form.

Old Town Village (OTV) will be working alongside partners from the neighborhood and Christ Church parish. OTV volunteers will focus on the Douglass Cemetery, which is directly behind 1404 Roundhouse (Building 4). Most of our work will consist of clearing out the wood debris, dead plants, ivy, and trash from the Cemetery. We will also lay new mulch along the path from OTV parking to Jameson Street.



Water and garbage bags will be provided.

We recommended that you wear a long-sleeved shirt, long pants, comfortable shoes, a sun-protective hat, and work gloves. There is poison ivy in the area, and we will be pulling grass weeds and wood out with our hands, which is why we recommend the work gloves. In addition, please bring these tools if you have them: Shovels, Pitch Forks, Rakes, Hedge Trimmers, Pruning Shears, Hand Saws.

The impact OTV has made over the last 18 years in maintaining the complex and the abandoned cemeteries cannot be overstated. Please pass this information on to anyone who may be interested in volunteering to help us.



Groundbreaking for Inova Alexandria Hospital at Landmark announced for Sept. 30

Inova Alexandria Hospital at Landmark will break ground on Monday, Sept. 30.

Today the hospital system announced the groundbreaking for the 1.1 million-square-foot project located at the former Landmark Mall.

Inova at Landmark includes a 569,000 square-foot hospital center, a 111,000 square-foot cancer center, an 83,000 square-foot specialty care center and a retrofitted 550-space parking garage. A 1,488-space below-grade parking garage is also planned with at least 19 parking spaces set aside for electric vehicle charging.

City Council unanimously approved the project last

year, and Inova wants construction of the four-building hospital campus finished by 2028.

The groundbreaking event will begin at 2:30 p.m.

Alexandria's New Waterfront Art Installation Will Flood With Crowds

ALEXANDRIA, VA-A new waterfront art project is in the works, and early designs have a familiar theme: flooding. "Break Water" by Nekisha Durrett will be the seventh installation at Waterfront Park. It will be on view from March to November 2025. ALX Now first reported the news.

The Commission for the Arts approved the project in a unanimous vote. At a presentation last evening, the group showed various computer-generated images of how the project will look on the waterfront.

The centerpiece of the installation is a crafted steamboat wheel meant to represent the sidewheel from the River Queen. The vessel was commissioned for service in the Civil War and later became a passenger ferry. It was a recreational ship in the early 20th century. Its history will be reflected in the piece, with a shuffleboard court or other games of that time on a mural nearby.

Sandbags, real and/or fake, will support the wheel, and they could feature a number of symbolic images. These have multiple meanings, including preparation prior to flooding in this city and the sandbags covering the Duc de Richelieu Monument in Odessa, Ukraine, to prevent the landmark from being destroyed.
